on January 10, 2025 and must be returned no later than February 10, 2025. The election will be conducted by ballot and there will be no nominations from the floor when there is only one nominee for each position to be filled. The minimum signatures to nominate a candidate by petition will be 128, which is one percent of the membership. In the event there is more than one candidate for each position, voting at the annual meeting will take place by written ballot. The election/voting will take place in its order of business during the annual meeting.

Security Center | *Be proactive and help prevent fraud!*



PHONE SCAMS! We have all heard of them, but did you know that scammers are now using AI as a tool to further deceive people! Yes, scammers are using Artificial Intelligence (AI) to impersonate trusted entities, such as banks! The cybersecurity community is calling this "voice cloning." Scammers are using AI-generated voice software which makes it harder for individuals to distinguish between legitimate calls and fraudulent ones.

To prevent falling victim to these types of scams follow these steps:

- Always verify the caller's identity by questioning them or by simply hanging up and contacting the organization or person directly using verified contact information.
- Be cautious when answering unsolicited calls. If you receive an unexpected call, especially one asking for personal or financial information, tell the caller that you feel uncomfortable sharing this information and prefer an in-person or more secure way of communicating your information.

- Use Call-Blocking Apps! Install a call-blocking or spamfiltering app that can help screen potential scam calls. Check and see if your phone carrier offers one. A great tool to look at is the FCC's Consumer Guide on Call Blocking Tools and Resources, which offers information about various call blocking and labeling tools. Visit https://www.fcc.gov/call-blocking.
- Do your due diligence and keep up-to-date on the latest scam tactics. Spend a few minutes a week and research information on the latest scams and method criminals are using.
- Lastly, if you believe you've been scammed or even if you just received a suspicious phone call — report it to the appropriate authorities, such as the Federal Trade Commission (FTC) or your State Attorney General's Office. To report a scam, visit the FTC's website at ReportFraud.ftc.gov.

By staying vigilant and sharing your experiences, you can help protect others from falling victim to similar scams. Spread the word among your family and friends so they can safeguard themselves from becoming the next target.

Remember, we will <u>never</u> call and ask for your debit card number, online banking information, or any type of verification code. If you ever get a call from anyone claiming to be from U S Federal Credit Union asking for any type of account or personal information "for verification" just hang up and call us directly at **219-769-1700**.
